S/B	From 8 U.S. Code § 1401: the following shall be nationals* and citizens of the United States at birth:
	A person born in the United States, and subject to the jurisdiction thereof
	A person born in the U.S. to a member of an Indian, Eskimo, Aleutian, or any other aboriginal tribe (as long as citizenship does not impact the person's status as a citizen of the tribe)
	A person born outside of the United States and U.S. possessions of parents both of whom are citizens of the United States and one parent has had a residence in the U.S. or a U.S. possession prior to the birth of the person
	A person born outside of the United States and its outlying possessions to a parent who is a citizen of the United States who has been physically present in the United States or one of its possessions for a continuous period of one year prior to the birth of such person, and the other of whom is a U.S. national, but not a citizen of the United States
	A person born in a U.S. possession of parents one of whom is a U.S. citizen and was physically present in the U.S. or a U.S. possession for at least one continuous year prior to the birth of the person
	A person of unknown parentage found in the United States while under the age of five years, until shown, prior to his attaining the age of twenty-one years, not to have been born in the United States
	A person born outside the United States and its outlying possessions to one parent who is a foreign national and the other parent is a U.S. citizen and the U.S. citizen parent was physically present in the United States for at least 5 years, including at least 2 years after 14 years of age
	A person born before noon (Eastern Standard Time) May 24, 1934, outside the limits and jurisdiction of the United States of an alien father and a mother who is a citizen of the United States who, prior to the birth of such person, had resided in the United States

*U.S. citizens are also U.S. nationals. Persons born in American Samoa and Swains Island are generally considered nationals but not citizens of the United States.


